DESCRIPTION

FIG. 1 is a top plan view of a decorative stud holder showing my new design;

FIG. 2 is a bottom plan view;

FIG. 3 is a right side elevational view, the left side elevational view being a mirror image;

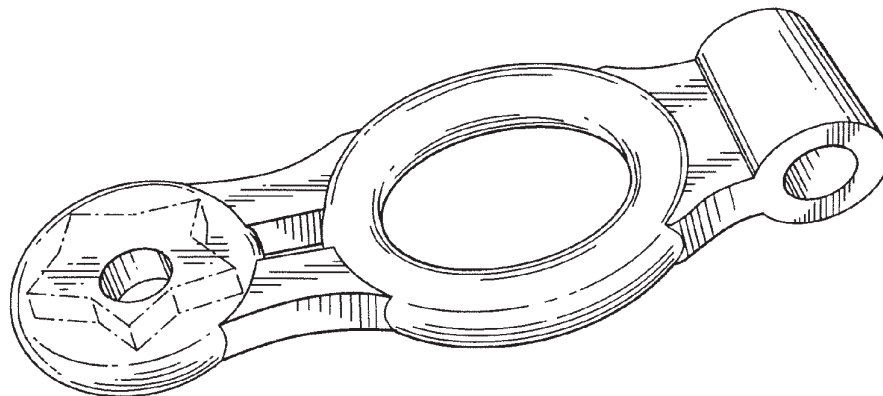
FIG. 4 is a front elevational view;

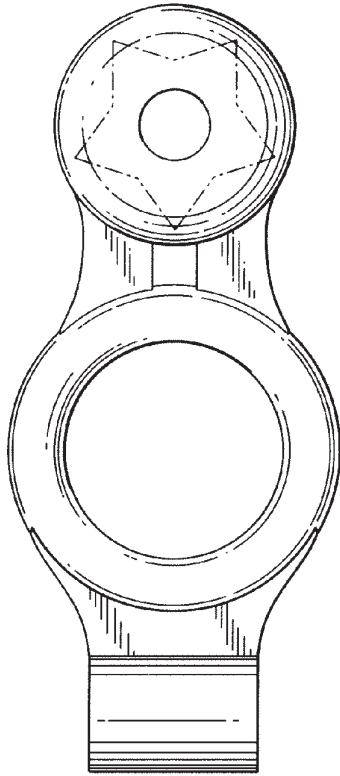

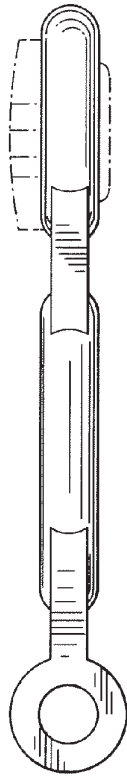

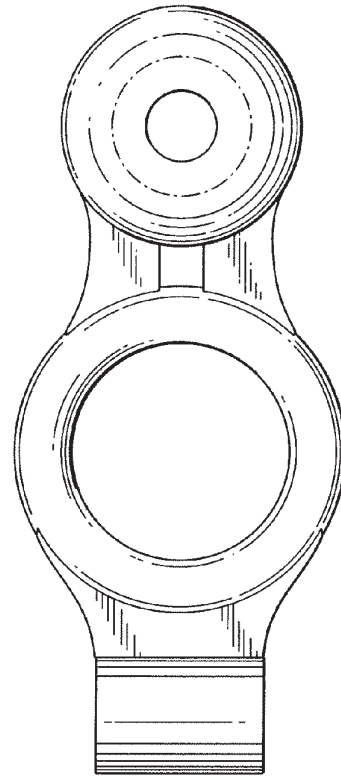

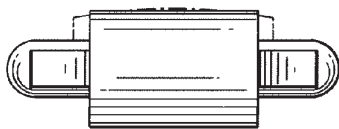

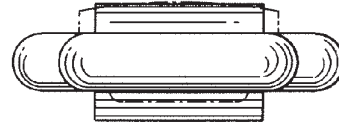

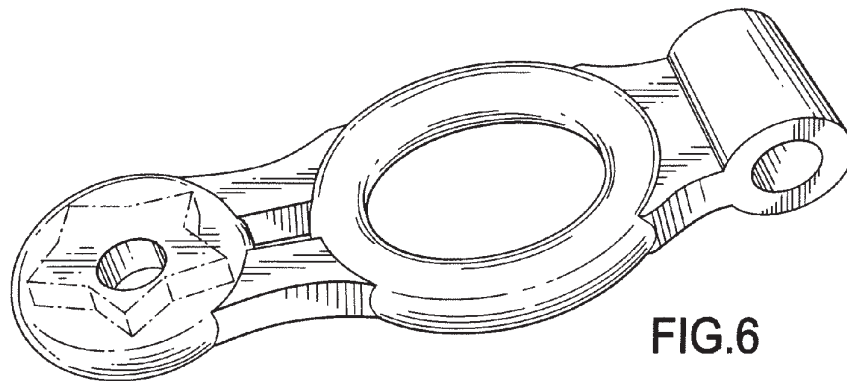
