The ornamental design for a pet collar, as shown and described.

DESCRIPTION

FIG. 1 is a top and bottom plan view, which are mirror images, of the design for the pet collar. The prongs and the lower loop and leash portion are shown in dotted lines, are for illustrative purposes only, and are not part of the claimed design.

FIG. 2 is a front elevation view of FIG. 1.

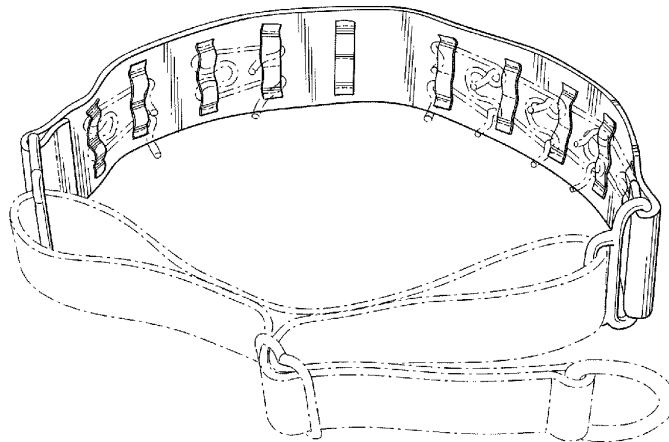
FIG. 3 is a rear elevation view of FIG. 1.

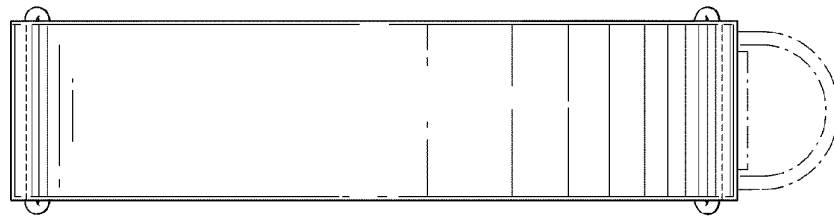

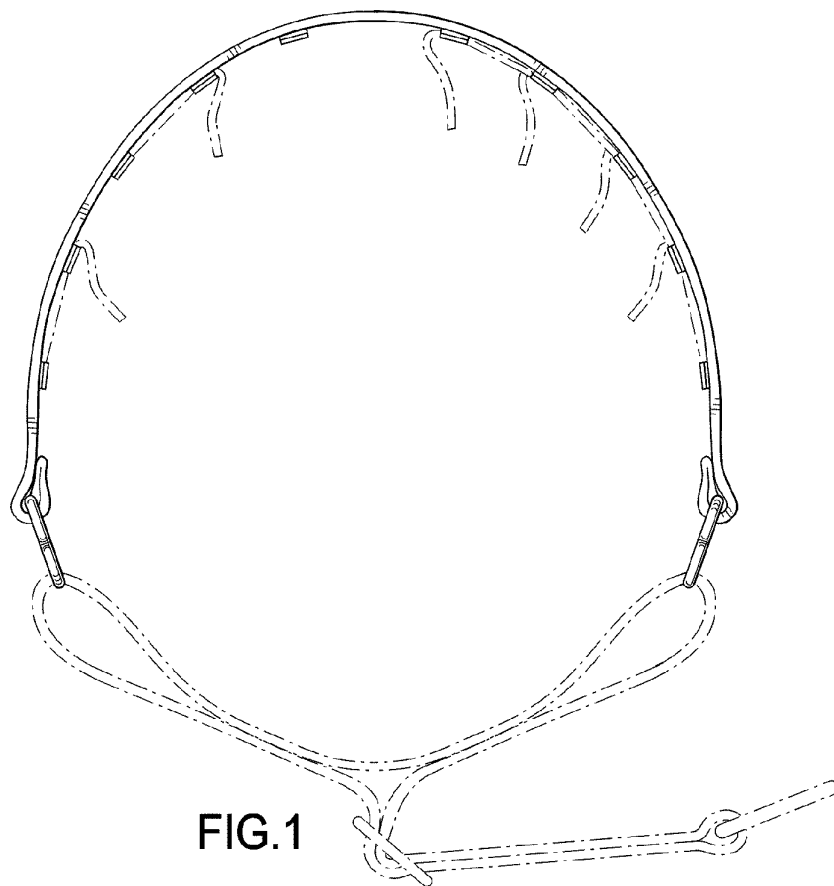

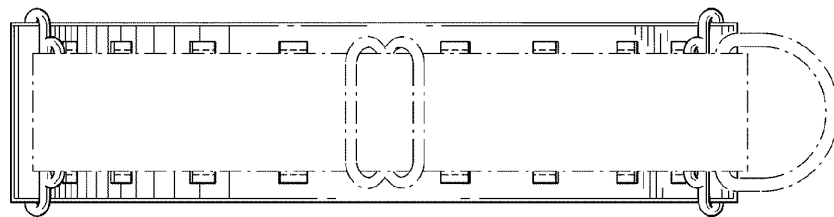

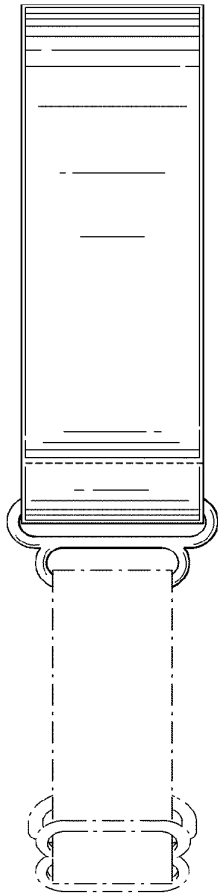

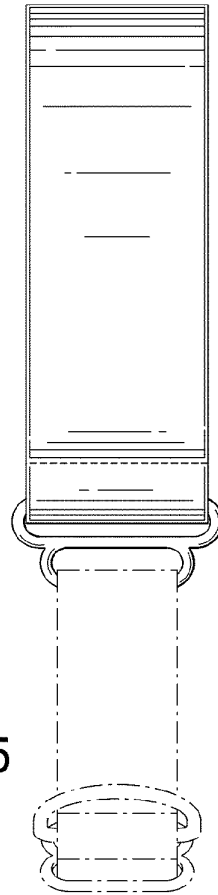

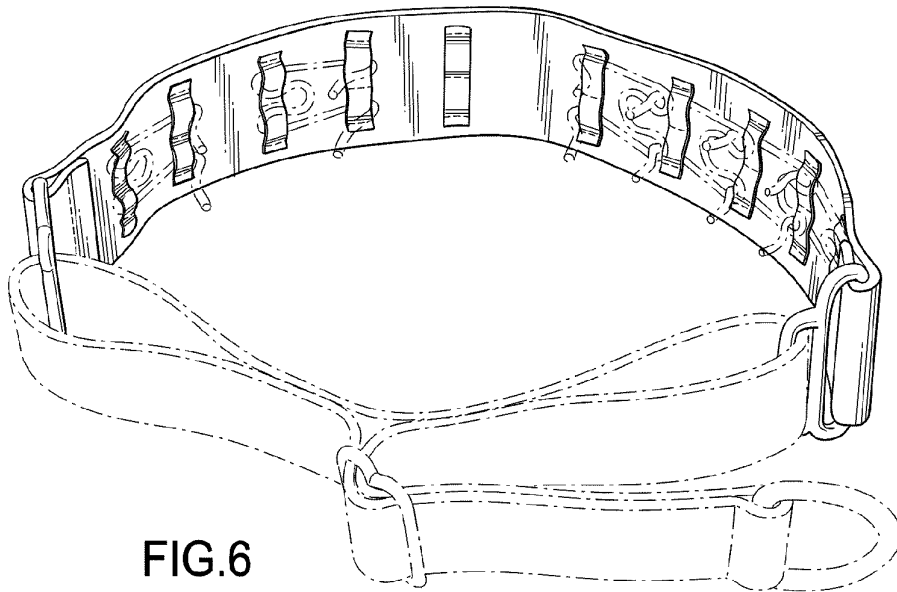
